The Sahapedia-UNESCO Fellowships 2018

TERMS AND CONDITIONS

- 1. The Sahapedia–UNESCO Fellowship has to be completed within the time-frame of 24 weeks to specification.
- The total award is of ₹40,000, which is inclusive of both honorarium and other expenses incurred in the course of the assignment. An additional amount of ₹10,000 will be provided for translation costs to Fellows working in regional languages.
- 3. The list of four deliverables constituting a Fellowship provided as part of the application has to be strictly adhered to.
- 4. Within the framework of the specified 24 weeks of the Fellowship, the details of the timeline for individual Fellows will be fixed a on mutual agreement. The subsequent installments will be released on completion of the work as set out in this plan.
- 5. Sahapedia will make the aforementioned amount available in three installments, 20% upon signing of this agreement, 40% upon submission of the first and fourth deliverable, and 40% upon completion of the assignment to the satisfaction of Sahapedia.
- 6. The first installment will be released following the formal acceptance of the terms and conditions contained in this document. Selected candidates holding an Indian PAN card will also be required to provide a copy before the funds can be released.
- 7. All material created and curated for the module will be uploaded on Sahapedia. Sahapedia is committed to the Creative Commons approach, to maximize the potential of the Internet to widen access to research, knowledge and artistic creativity, with full

credit to creators. It will be licensed under the IPR policy of Sahapedia (CC-BY-SA 4.0). The Fellow will be credited for the work submitted.

- 8. Sahapedia and UNESCO will have the unfettered right of/to use and/or reproduce the whole or parts of the work arising out of the award in any of its publications without additional permission or payment.
- 9. Sahapedia and UNESCO are absolved of any liability, if this work has appeared in any medium without the knowledge or permission of the Fellow.
- 10. Sahapedia and UNESCO will have no obligation under Sections 51, 63 and 65 of the Indian Copyright Act, 1957 to the extent of any claim of infringement or misappropriation resulting from:

(i) The use of this work in combination with any other work or materials not provided by the Fellow, except where such combination is reasonably necessary for the Intended Use of this work.

(ii) Any third party claim arising in regards to this work.

11. The Fellow will indemnify and defend Sahapedia and UNESCO, and each of its respective officers, employees, agents, and assigns, or any of them from (hereafter collectively known as "Indemnified Parties") and against all claims, suits, demands, actions, causes of action, proceedings, judgments, assessments, deficiencies, and charges brought against the Indemnified Parties for all damages, losses, costs, liabilities, and expenses (including reasonable attorney and professional fees and costs) arising from or incidental to Claims, which in whole or in part, directly or indirectly violate any Intellectual Property rights of any third party.

- 12. Requests related to extension of time-period and allocation of funds during the period of the Fellowship may be made directly to the Project Executives for Sahapedia.
- 13. The timeline mentioned above should be strictly adhered to. Additionally, the work should conform to specification and the standards of content creation on Sahapedia.
- 14. Failure to complete work on time or to specification will result in the cancellation of the Fellowship. All advances made will be repayable to Sahapedia, unless informed to and approved by Sahapedia, in writing.
- 15. The Fellow will be liable to forfeiture of the award upon the institution of judicial proceedings of civil or criminal nature against them.
