

Sahapedia Film Fellowship 2020

Terms and Conditions

The selected candidates will be recognised as Sahapedia Film Fellows for 2020 on meeting these conditions:

1. Selected candidates are required to complete the film deliverables within the nine months spanning January 1, 2020, and September 30, 2020.
2. The fellowship grants an award of INR 1,75,000 (One Lakh Seventy Five Thousand only), which is inclusive of both an honorarium and other expenses incurred in the process of completion of the assignment. Applicable Income Tax will be deducted at source as per the provisions of the Income Tax Act, 1961.
3. Sahapedia will make the aforementioned amount available to the selected candidates in three instalments, 40% of the fellowship amount after signing the agreement, 40% of the fellowship amount upon satisfactory submission of the first draft of the film and 20% of the fellowship amount upon completion of the fellowship to the satisfaction of Sahapedia.
4. The first instalment (40% of total amount) will be released upon receipt of the copy of the selected candidate's PAN card, cancelled cheque/bank account details and a formal acceptance of the letter of agreement.
5. The subsequent instalments will be released on completion of the work to the satisfaction of Sahapedia. Typically, Sahapedia will require four to six weeks to assess and review submissions. Payment will be released thereafter.
6. A monthly progress report via email is expected from the selected candidate. A preliminary budget for the assignment must be provided within the first month.
7. All material created will be uploaded to Sahapedia's online portal. Sahapedia will have unlimited rights to use and/or reproduce the whole or parts of the work arising out of the award in any publication/s or in any medium whatsoever without additional permission or payment. Due credit will be given in any such instances.
8. Sahapedia reserves the right to take down any content found unsatisfactory and/or controversial or any other reason that Sahapedia deems fit.

9. Sahapedia stands absolved of any liabilities, if the selected candidate's Fellowship work appears in any medium without their knowledge or permission.
10. Sahapedia shall have no obligation under Sections 51, 63 and 65 of the Indian Copyright Act, 1957 to the extent of any claim of infringement or misappropriation resulting from any third-party claim arising regarding this work. The work submitted by the fellow to Sahapedia must be an original piece of work and not reproduced in any way from any other medium. All submitted work shall be subjected to rigorous scrutiny by anti-plagiarism software.
11. The selected candidate, shall indemnify and defend Sahapedia, and its respective officers, employees, agents and assigns, or any of them from (hereafter collectively known as "Indemnified Parties") and against all claims, suits, demands, actions, causes of action, proceedings, judgments, assessments, deficiencies and charges brought against the Indemnified Parties for all damages, losses, costs, liabilities and expenses (including reasonable attorney and professional fees and costs) arising from or incidental to claims, which in whole or in part, directly or indirectly violate any IPR of any third party.
12. In the case of failure on the part of the selected candidate to:
 - a. Submit stipulated deliverables to the satisfaction of Sahapedia,
 - b. Adhere strictly to timelines and schedules, and
 - c. Submit monthly progress reports

Sahapedia reserves the right to terminate this fellowship. Upon termination of the fellowship for any reasons whatsoever Sahapedia reserves the right to recover any advance payments, withhold further payments and withhold issuance of fellowship certificate. In the case of termination, Sahapedia shall inform the selected candidate in writing. In the case of termination due to any of the reasons above the selected candidate will not be recognised as a Sahapedia Film fellow.
