

ANNEXURE I

COPYRIGHT LICENCE AGREEMENT

(Copyright License Agreement for Photographer – Sahapedia Frames Photography Grant)

This is to certify that I, **Name of Grantee**, currently resident of **(Address)** and being a **permanent resident of (Address)** have been selected for receiving the Sahapedia Frames Photography Grant by Sahapedia vide letter-cum-agreement **(Date)**, to create/compose/produce/share a Photo Essay on the theme of **'Project title'** thereto:

1. In consideration of full and final payment of Rs. 50,000/40,000 (Rupees in words) that has been duly received by me, I being the author and owner of copyright in the Photo Essay hereby grant irrevocable rights in favor of Sahapedia in respect of contents of the Photo Essay as listed in Schedule I for perpetuity and for territories of the world to host, display, disseminate, share, communicate to public the contents of the Photo Essay on their website or any other electronic medium or publish the same in any manner by itself or in conjunction with any other work. No rights being granted to Sahapedia, or any part thereof, shall lapse due to non-exploitation or utilization thereof by Sahapedia within one year of the Photo Essay being submitted. Sahapedia shall have the right to modify, adapt, alter the contents of the Photo Essay, or any part thereof, in order to use the same for their purpose. Rights so granted in favor of Sahapedia shall include the following:
 - (a) Right to utilize the contents of the Photo Essay by way of storing, hosting, performing and communicating to public on Sahapedia's digital platforms including but not limited to "www.sahapedia.org";
 - (b) Utilize the Photo Essay, or any part thereof, by itself or in conjunction with any other material for its purpose for hosting, storing, displaying, publishing (including by way of printing in any material form) and distributing such published forms;
 - (c) Utilizing the Photo Essay, or any part thereof, by itself or in conjunction with any other form for making any audio or audio-visual material and utilize the said audio or audio-visual material in any manner including the storing, hosting, displaying, performing and communicating to the public;
2. I shall not use the contents of the Photo Essay delivered to Sahapedia within 12 months of signing of this, the Copyright License Agreement, and thereafter, only after intimation to Sahapedia at copyright@sahapedia.org. I retain the right to create original contents on the same themes/ideas/concept as created for Sahapedia.
3. I assure and promise that the contents of the Photo Essay delivered to Sahapedia shall be my own original work and any usage of Contents by Sahapedia shall not infringe any right of any person and such usage shall not be infringement of any right of any person. I undertake and agree to indemnify and keep Sahapedia indemnified from any action, cost or damage arising out of any breach of this promise.
4. I undertake to keep any confidential or strategic information that I may receive in relation to Sahapedia as confidential and shall not disclose, share, communicate or disseminate the same to any person in any manner and understand that this obligation shall continue even after completion/termination of the agreement letter dated.....
